

PS: 1612-2014 (2nd Revision)-STEEL FOR THE REINFORCEMENT OF CONCRETE WELDABLE REONFORCING STEEL-BAR, COIL AND DECOILED PRODUCT-SPECIFICATION

PS: 1879-2018 (Revised)-DEFORMED AND PLAIN CARBON-STEEL BARS FOR CONCRETE REINFORCEMENT

02. ALL Approved drawings must mention any of the above two (02) Standards on which design has been prepared to ensure tracking and traceability of each lot of bars used in construction.
