It will be our pleasure to issue the badges and to complete the registration for your team members. Attached you will find the guidelines for your reference to complete the application forms.

The guidelines should be followed carefully particularly the requirements showing the financial strength of the organisation. I would like to mention that the visa issued shall be a business visa and the visa invitation letter will be only issued to the relevant, active and proven members of the companies (Active Directors, Managers etc). We cannot issue the badges and invitation letters for family members who may wish to travel with the applicant. It may take three to four weeks for Schengen visa to be processed. If there are any plans to travel before ITMA kindly take this duration into account.

You are kindly requested to complete the attached Excel sheet for the interested team members and send it to us along with the copy of passports and previous Schengen visas if any along with the deposit slips after making the payment in our bank account.

Badges and Invitation Letters:

The visitor registration Processing Fee (7 day visitor Badge, Invitation Letter, Banking Charges and Courier) is **Rs. 13,000/-** per application.(Members of textile associations only). This amount is non refundable.

If your organisation is not a member of any textile association in Pakistan the total charges shall be Rs. 17750/-

As soon as we receive the proof of payment (bank deposit slip) in the following bank account, we shall be able to send the badges and the invitation letter via express courier as well as the email.
