**ELECTION FOR 06 (SIX) VACANT SEATS ON NORTHERN CIRCLE COMMITTEE & 02 (TWO) VACANT SEATS ON CENTRAL EXECUTIVE COMMITTEE:**

1. **AS PER T.O RULES 2013 SECTION 15 ELIGIBILITY TO VOTE** – (1) Subject to provision of section 10 of the Act, the eligibility of a member of trade organization to vote at the elections of the trade organization shall be subject to following conditions namely
- The member has completed two years of valid membership of the Trade Organization as on the date of announcement of election schedule by the Executive Committee of the Trade Organization:  
**“Provided that old members shall be eligible to vote on completion of one year of their enrolment and payments of all dues”; and**
  - The member has fulfilled the conditions of membership and renewal thereof of the respective trade organization under rule 11.
