Sales tax on light diesel abolished

ISLAMABAD: The Federal Board of Revenue (FBR) has abolished sales tax on light diesel oil from January 16, 2022. According to a notification issued by the FBR here on Thursday, the general sales tax (GST) on petrol has been reduced from 2.50 percent to 0.79 percent, showing a decrease of 1.71 percent.

Rs273bn KCR project sent to ECNEC

ISLAMABAD: The Central Development Working Party (CDWP) cleared the Karachi Circular Railway (KCR) as a Modern Urban Railway project at a cost of Rs273.1 billion, while referring it to the Executive Committee of the National Economic Council (ECNEC) for final approval.
