Tax Laws (Third Amendment) Ordinance, 2021

Sec 45(2) of Customs Act: Amendment to IGM under WeBOC couldn't be carried out: SHC

KARACHI: Sindh High Court (SHC) has declared that amendment to Import General Manifest (IGM) under WeBOC system in terms of Section 45(2) of the Customs Act, 1969 couldn't be carried out.

July-August: Textile group exports witness 28.67pc growth

ISLAMABAD: The country's textile group exports witnessed 28.67 percent growth during the first two months (July-August) of current fiscal year and remained \$ 2.933 billion compared to \$ 2.280 billion during the same period of last fiscal year, says the Pakistan Bureau of Statistics (PBS).

Jul-Aug period: CA posts \$2.2bn deficit on higher import bill

KARACHI: The country's current account posted a \$2.2 billion deficit during the first two months of this fiscal year on the back of higher import bill.

FDI declines 20pc in two months

KARACHI: The Foreign Direct Investment (FDI) posted a negative growth during the first two months of this fiscal year.

Incremental consumption: CCoE approves winter incentive package

ISLAMABAD: The Cabinet Committee on Energy (CCoE) Friday approved the summary submitted by the Power Division on the winter incentive package on incremental consumption for all domestic, commercial, and general services consumers of XW-DISCOs and K- Electric from 1st November 2021 till 28th February 2022.

Regulator may not allow KE to collect KMC tax

ISLAMABAD: National Electric Power Regulatory Authority (Nepra) Friday indicated that it would not allow Karachi Electric (KE) to collect Municipal Utility Charges and Tax (MUCT) from citizens on behalf of Karachi Metropolitan Corporation (KMC), as it does not fall within the purview of the executive.

Nadra empowered to share citizens' details with FBR

ISLAMABAD: The government has given legal backing to the National Database and Registration Authority (NADRA) to compute indicative income and tax liability of any citizen by use of artificial intelligence, mathematical or statistical modelling or any other modern device or calculation method.

Discussion on Ogra (Amendment) Bill, 2021 remains inconclusive

ISLAMABAD: A parliamentary panel, on Friday, pended discussion on the Oil and Gas Regulatory Authority (Amendment) Bill, 2021 due to the absence of Chairman OGRA. The Committee opined that public functionaries should accord priority to the parliamentary business.

UK decides to remove Pakistan from 'Red List'

ISLAMABAD: The United Kingdom has decided to remove Pakistan from its "red list" for international travel along with seven other countries, effecting from September 22, 2021 at 4am.

Textile, clothing exports grow 29pc in 2MFY22

ISLAMABAD: Pakistan's textile and clothing exports posted impressive growth in the first two months of this year increasing by 28.67 per cent to \$2.93 billion compared to \$2.28bn over the year, data released by the Pakistan Bureau of Statistics (PBS) showed on Friday.

Alarm as current account deficit balloons to \$1.5bn in August

KARACHI: The current account deficit (CAD) has increased by a whopping 81 per cent in August to \$1,476 million compared to July during this fiscal year (FY22), mainly because of an ever-rising imports bill.

Tarin tasks FBR with achieving 20 percent tax-to-GDP ratio

To discourage gas consumption: Flat tariff of Rs12.66 per unit on incremental power use for winters

ISLAMABAD: With a view to discourage use of gas in winters on account of dwindling local gas production, costly import of LNG and to cope with the gas crisis, the government has approved a four-month incentive package on incremental consumption for electricity consumers that includes domestic, commercial and general services to encourage the maximum use of electric power for heating purposes.

CCoP rejects domestic gas tariff hike proposal

ISLAMABAD: The Cabinet Committee on Energy (CCoE) on Friday turned down the upward revision of domestic gas price during winter for high slab consumers.

Presidential ordinance: FBR can now block SIMs, disconnect utility connections

ISLAMABAD: With the promulgation of the presidential ordinance for broadening of the tax base, the government has granted sweeping powers to the Federal Board of Revenue (FBR) for disconnection of mobile phones/SIMs, electricity, and gas connection of non-filers.

C/A deficit widens 81 percent to \$1.47bln in August

KARACHI: Pakistan's current account deficit jumped 81 percent month-on-month in August as a strong demand spurred imports amid higher commodity prices, outpacing a recovery in exports.

FDI falls 20pc to \$203.1mln in July-August

KARACHI: Pakistan's foreign direct inflows dropped 20.3 percent to \$203.1 million in the first two months of the current fiscal year of 2021-22, the central bank's data showed on Friday.
