Budget preparation exercise: Process marred by political instability

ISLAMABAD: The budget-making process for next fiscal year is limited to fixed expenditure as International Monetary Fund (IMF) endorsement is critical for generating external financing while the prevailing political uncertainty in the country has slowed down economic activities.

Cash crunch haunts textile exporters

LAHORE: The textile sector has been facing a financial crunch because of delayed shipments, non-availability of containers, high cotton and polyester prices and refusal of foreign buyers to increase rates, which could push spinning mills to close their units by April.

Gas utility seeks 66% price hike

Businessmen irked over diversion of gas

Businessmen have expressed agitation over diversion of Sindh's gas to the SNGPL network and termed it unjust move. In a joint statement on Wednesday, several chambers and businessmen lobbies of Karachi said that it was against Article 158 of Pakistan's constitution and called it imprudent action at a time when industries of Karachi had been suffering from gas shortages.
