New property valuation rates held in abevance

ISLAMABAD: The Federal Board of Revenue (FBR) on Tuesday held in abeyance the new property valuation rates till January 16, 2022, according to an announcement of the FBR.

Reduced rate of GST on petrol abolished

ISLAMABAD: The Federal Board of Revenue (FBR) has abolished the reduced rate of 1.43 percent sales tax on petrol from December 7, 2021.

FCA for September: KE tariff hiked by Rs3.76

ISLAMABAD: National Electric Power Regulatory Authority (Nepra) has increased Karachi Electric's (KE's) tariff by Rs 3.76 per unit for September 2021 under monthly Fuel Component Adjustment (FCA) mechanism across the board except lifeline consumers.

Export-oriented units: Punjab govt says will take gas price hike matter up with federal govt

LAHORE: Punjab Minister for Industries and Trade Mian Muhammad Aslam Iqbal has assured All Pakistan Textile Mills Association (APTMA) of taking up the issue of gas price hike from \$6.5/MMBTU to \$9/MMBTU for export oriented units in Punjab with the federal government at all appropriate levels while agreeing that it has led to a huge price disparity among provinces.

KARACHI: The petitions filed by the Federation of Pakistan Chamber of Commerce and Industry (FPCCI) and other trade bodies, etc., challenging the minimum rate of wages fixed by the Government of Sindh at Rs 25,000 per month were taken up for hearing by the Supreme Court of Pakistan at Islamabad.

Sindh govt, IFC sign pact: Project aimed at boosting water supply to Karachi

KARACHI: The Sindh government and the IFC, a member of World Bank Group, signed a landmark agreement on Tuesday at the CM House to help the provincial government to structure a public-private partnership project that would provide clean drinking water to nearly one million people of Karachi.
