July C/A deficit falls 78pc YoY on remittances

KARACHI: The country's current account fell sharply, ie, 78 percent during the first month of this fiscal year (FY25) supported by healthy home remittances inflows. The State Bank of Pakistan (SBP) on Monday reported a significant improvement on external account with a massive decline in the current account deficit.

MoC says taking efforts to bring down ACD to zero

KARACHI: Following the successful milestone of technical bid opening for K-Electric's 150 MW solar energy projects in Balochistan, the company marked another important milestone with the opening of the financial bids at a private event in Karachi.

Textile sector's 'breaches' inflict financial 'turmoil' on PCCC

At the time of Pakistan's independence, the country had only two textile mills and a handful of ginning factories, producing a modest 1.5 million bales of cotton with an average yield of 370 kilograms per hectare.

THE RUPEE PKR: minor improvement

KARACHI: The Pakistani rupee registered minor improvement, appreciating 0.05% or Re0.10 to close at 278.44 against the US dollar in the inter-bank market on Monday. On Friday, the rupee had settled at 278.54 against the greenback, according to the SBP.

Spot rate gains Rs300 per maund amid slow trading

The Spot Rate Committee of the KCA on Monday increased the spot rate by Rs 300 per maund and closed it at Rs 17,800 per maund. Cotton Analyst Naseem Usman told BR that the local cotton market remained steady and the trading volume remained low.

Current account deficit narrows by 78pc in July

KARACHI: Pakistan's current account deficit (CAD) narrowed by over 78 per cent in the first month of FY25, which is a positive sign for the economy. On Monday, the State Bank of Pakistan (SBP) reported that the country posted a CAD of \$162 million in July against \$741m in the same period last year.

ISLAMABAD: The Senate Standing Commit-tee on Energy (Power) on Monday asked the Power Division to provide original agreements with all the Independent Power Producers (IPPs) along with a report on the comparison of similar contracts in other countries.

Bid for 150MW solar project

KARACHI: K-Electric on Monday received the lowest tariff bid for its 150-megawatt renewable energy projects in Balochistan, to be started by Q4FY25. KE will submit a bid evaluation report to the National Electricity Power Regulatory Authority after which it will announce the successful bidder.

C/A deficit hits \$162m in July

Govt expands traders' tax scheme

Dar rules out change in CCI decision on gas supply

ISLAMABAD: Deputy Prime Minister Ishaq Dar, who is also chairman of a committee on gas supply issues, has told the Petroleum Division that no change would be made in the decision of the Council of Common Interests (CCI), which has allowed an increase in gas allocation to third parties by exploration and production (E&P) companies.
