KARACHI: Pakistan International Airlines (PIA) will resume twice-weekly flights between Islamabad and Paris starting January 10, 2025, following the European Union's removal of restrictions on the carrier.

PKR: marginal decline

KARACHI: The Pakistani rupee recorded a marginal decline against the US dollar, depreciating 0.03% in the inter-bank market on Friday. At close, the currency settled at 278.01, a loss of Re0.07 against the greenback. On Thursday, the rupee had settled at 277.94, according to the State Bank of Pakistan (SBP).

Gold prices fall

KARACHI: Gold prices declined fairly on Friday following a dip in the international rates, traders said. Gold lost value by Rs1,000 and Rs857, selling for Rs274, 700 per tola and Rs235, 511 per 10 grams, separately.

Modest trading on cotton market

Cotton Analyst Naseem Usman told Business Recorder that the rate of cotton in Sindh is in between Rs 16,000 to Rs 18,000 per maund. The rate of Phutti in Sindh is in between Rs 6,500 to Rs 7,500 per 40 kg.

PBC sees 200bps cut in policy rate

KARACHI: Pakistan Business Council (PBC) has said that a decrease of about 200bps in the policy rate on Dec 16 appears feasible, with more to follow in early 2025, provided inflation remains tame. "This cut will bring the policy rate close to the 3+ months KIBOR rate, which is about 12.5pc at present," said PBC chief executive Ehsan Malik on Friday.
