Improved macro indicators: Govt explains approach to economy

KARACHI: Federal Minister for Finance and Revenue, Senator Muhammad Aurangzeb on Saturday said macroeconomic indicators of the country are moving in positive direction with declining inflation, improving balance of payment, rupee stability and strengthening foreign exchange reserves.

Advisor outlines key economic policies, initiatives

Trade cargo: Govt opens borders to registered Azeri vehicles

ISLAMABAD: The Federal Board of Revenue (FBR) will allow entry of Azerbaijan's registered vehicles transporting transit and bilateral trade cargo into Pakistan. The FBR has issued an SRO.2016(I)/2024 to notify draft Azerbaijan-Pakistan Transit Trade Rules 2024 under the Azerbaijan-Pakistan Transit Trade Agreement, 2024 for processing of transit trade cargo through the specified ports under Customs Computerized System, to and from Azerbaijan.

Bangladesh and Pakistan vow to increase bilateral trade

KARACHI: Bangladesh and Pakistan vowed to increase the bilateral trade volume with wider business-to-business engagements. Bangladesh Deputy High Commissioner in Karachi S.M. Mahbubul Alam paid an official visit to Hyderabad.

Spot rate unchanged on cotton market

LAHORE: The local cotton market on Friday remained steady and the trading volume remained satisfactory. Cotton Analyst Naseem Usman told Business Recorder that the rate of cotton in Sindh is in between Rs 16,000 to Rs 18,000 per maund. The rate of Phutti in Sindh is in between Rs 6,500 to Rs 7,500 per 40 kg.
