The plan to hold a nationwide strike is intact and it will be implemented with full preparations, said Javed Balwani.

KARACHI: Karachi Tax Bar Association (KTBA has requested the Federal Board of Revenue (FBR) to extend the e-filing deadline for June 2025 sales tax returns to July 30, due to operational challenges with the IRIS portal's authentication system that are preventing timely compliance.

# LSM remains stuck in the past

Pakistan's large-scale manufacturing (LSM) sector continues to flirt with the idea of recovery, but the data tells a different story. May 2025 posted a modest 2.29 percent year-on-year increase — the second monthly rise this calendar year — but the bigger picture remains unflattering. Cumulative LSM growth for 11MFY25 stands at negative 1.21 percent, marking the tenth consecutive month of contraction.

# PKR: 0.10pc decline

KARACHI: The Pakistani rupee weakened against the US dollar, depreciating 0.10% in the interbank market on Wednesday. At close, the currency settled at 284.96, a loss of Re0.29. On Tuesday, the currency settled at 284.67.

#### **Gold prices sharply down**

KARACHI: Gold prices slipped significantly on Wednesday, as global rates receded under \$3,350 per ounce, traders said. Bullion trading on the global front lost momentum, sliding by \$30 to \$3,335 per ounce. The drop also pushed back the local market, APSGJA said.

#### **Modest business on cotton market**

LAHORE: The local cotton market on Wednesday remained steady and the trading volume remained satisfactory. Cotton Analyst Naseem Usman told Business Recorder that the rate of new cotton in Sindh is in between Rs 16,500 to Rs 16,600 per maund and the rate of cotton in Punjab is in between Rs 16,100 to Rs 16,300 per maund.
