Economic team meets China's finance minister: Pakistan explains its approach to challenges

'Tax fraud' definition expanded under revised ST Act 1990

ISLAMABAD: The "tax fraud" would cover any person, who would make taxable supplies without getting sales tax registration from the FBR. The updated Sales Tax Act 1990 has incorporated sales tax amendments introduced through Finance Act 2024 including new definition of "tax fraud".

Political turmoil, tax-laden budget: Businesses say Shehbaz govt 'worse manager' of economy: Gallup

KARACHI: Calling the government of Prime Minister Shehbaz Sharif as 'worse manager' of the economy, the country's business owners have become more pessimistic about their future because of continued political turmoil and the new tax-heavy budget, according to a latest survey.

ISLAMABAD: Appellate Tribunal Inland Revenue Islamabad Bench (ATIR) held that Federal Board of Revenue's field formations have adopted a new strategy to block refunds on the basis of "time limitation" issue and reclassification of tax nature.

KARACHI: Dubai's efforts to attract talented persons is reaping dividends as a greater number of Pakistanis are looking to relocated to the emirate, according to an immigration support services firm, which added that the city has now moved much beyond looking at just tourists to boost its economy.

Sindh and Balochistan: SSGC disconnects 1,182 illegal connections

KARACHI: Sui Southern Gas Company has sped up it's efforts to eliminate the incidences of gas theft. Over the past week, the Company's Customer Relations Department (CRD) along with the Security Services and Counter Gas Theft Operations Department (CGTO) carried out raids in multiple areas of Sindh and Balochistan.

Forex reserves fall by \$369m

The country's total liquid foreign reserves declined by \$369 million during the last week due to external debt servicing. According to the State Bank of Pakistan (SBP), the total liquid foreign reserves held by the country stood at \$14.335 billion as of July 19, 2024 compared to \$14.704 billion as of July 12, 2024.

PKR: slight improvement

KARACHI: The Pakistani rupee registered slight improvement, appreciating 0.03% against the US dollar in the inter-bank market on Thursday. At close, the currency settled at 278.41, a gain of Re0.09, against the greenback. On Wednesday, the currency had settled at 278.50 against the US dollar.

Gold prices fall

KARACHI: The local gold prices on Thursday slumped with the global bullion value going down below \$2400 an ounce, traders said. Prices of gold per tola nosedived by Rs2300 to Rs250500 and Rs1972 to Rs214763.

Spot rate drops further Rs500 per maund

LAHORE: The Spot Rate Committee of the Karachi Cotton Association (KCA) on Thursday decreased the spot rate by Rs 5,00 per maund and closed it at Rs 17,300 per maund. Cotton Analyst Naseem Usman told Business Recorder that local cotton market was near clash under the influence of New York Cotton Market.

ISLAMABAD: In light of the recent increase in base tariffs, government-owned power distribution companies (Discos) have sought an additional fuel cost adjustment (FCA) of Rs2.63 per unit to extract about Rs35 billion more from consumers in the next billing cycle for the electricity consumed in June.

ISLAMABAD: In line with the IMF agreement, the Federal Board of Revenue (FBR) has revised its annual tax collection target downward from Rs12,970 billion to Rs12,913 billion for the current fiscal year 2024-25.

JAKARTA: Indonesia launched a long-term visa scheme on Thursday intended to attract foreign investors, President Joko Widodo said, with amounts of up to \$10 million giving them a 10-year visa and access to Southeast Asia's largest economy.

SBP to meet on July 29 to decide monetary policy

The Monetary Policy Committee (MPC) of the State Bank of Pakistan (SBP) will meet on Monday, July 29, 2024 to decide on monetary policy. Governor SBP Jameel Ahmad will announce the monetary policy decision at a press conference on the same day after the MPC meeting.

SBP forex reserves drop by \$397m to \$9.02bn

KARACHI: Pakistan's foreign exchange reserves held by the central bank decreased by \$397 million to \$9.027 billion in the week ending July 19 due to external debt repayments, the State Bank of Pakistan reported on Thursday.

Pakistan plans rail links with Russia

ISLAMABAD: Pakistan has decided to outline a strategic road map to engage with Russia and connect the two nations via railway networks and secure trade routes by circumventing the threat of US sanctions.

Pakistan formally requests Chinese debt restructuring

ISLAMABAD: Pakistan formally requested China on Thursday to reschedule its debts, with outstanding dues for China-Pakistan Economic Corridor (CPEC) power projects increasing by 44% to Rs401 billion by the end of the last fiscal year. These unpaid debts, in violation of the 2015 CPEC Energy Framework Agreement, are hindering further financial and commercial relations between the two countries.

SIFC endorses refineries' demands

ISLAMABAD: The Special Investment Facilitation Council (SIFC) on Thursday backed plans to withdraw the budgetary measures that could lead to the closure of refineries and spoil a \$6 billion plant upgrade programme.

Business pessimism grows under 'worse' govt

KARACHI: The country's business owners have become increasingly pessimistic about their future due to ongoing political turmoil and the new tax-heavy budget, describing the federal government as a "worse" manager of the economy, according to a recent survey.

SSGC launches new high-pressure pipeline
