Moody's betters banking outlook on firm resilience

ISLAMABAD: Global rating agency Moody's has said that Pakistan's macroeconomic situation has improved with banking outlook upgraded from stable to positive, and the country's economy is set to register a three percent growth.

Potassium sulphate: ECC may approve export from Gwadar Port today

ISLAMABAD: The Economic Coordination Committee (ECC) of the Cabinet, which is scheduled to meet on Thursday (March 13), is likely to approve the export of potassium sulphate (K2SO4) from Gwadar Port, in addition to security charges for the Reko Diq Project to the Frontier Corps Balochistan (South).

KE submits negative FCA adjustment request for Jan

ISLAMABAD: The K-Electric (KE) has requested a provisional negative adjustment of Rs 4.84 per unit in the Fuel Charges Adjustment (FCA) for January 2025, which would pass on the financial impact of Rs 4.695 billion to its consumers. Additionally, the KE is seeking to adjust a pending amount of Rs 13.5 billion from previous months.

RLNG prices revised for March

The Oil and Gas Regulatory Authority (OGRA) has revised the prices of imported Re-gasified Liquefied Natural Gas (RLNG) for the month of March, making it more expensive for both gas companies - Sui Southern Gas Company (SSGC) and Sui Northern Gas Pipelines Limited (SNGPL).

THE RUPEE PKR: largely stable

KARACHI: The Pakistani rupee remained largely stable against the US dollar, depreciating 0.01% in the inter-bank market on Wednesday. At close, the currency settled at 279.97, a loss of Re0.02 against the greenback. On Tuesday, the rupee had closed at 279.95.

Gold prices move up

KARACHI: Gold prices edged higher on Wednesday, reflecting a slight momentum on the world market, traders said. Following a gain by Rs500 and Rs429, gold prices reached Rs306,500 per tola and Rs262,774 per 10 grams, respectively, according to APSGJA.

Spot rate loses Rs300 per maund amid slow activity

LAHORE: The Spot Rate Committee of the KCA on Wednesday decreased the spot rate by Rs 300 per maund and closed it at Rs 17,000 per maund. Cotton analyst Naseem Usman told Business Recorder that the local cotton market remained bearish and the trading volume remained low.

RLNG prices raised for March

Petrol may see Rs14 per litre reduction

ISLAMABAD: The prices of all petroleum products are estimated to fall by up to Rs14 per litre for the next fortnight, ending March 31, owing to fluctuation in the international market and import premiums. This relief is, however, subject to unchanged tax rates.

Oman offered Gwadar, Karachi ports use for access to Central Asia

ISLAMABAD: Pakistan has offered Oman the use of Gwadar and Karachi ports for greater access to emerging markets in Central Asia. The offer was made during a high-level meeting between Commerce Minister Jam Kamal and his Omani counterpart, Qais Al Yousif in Muscat this week.

KE seeks Nepra's nod to refund Rs4.84 per unit in April bills

ISLAMABAD: K-Electric (KE) has filed a petition with the National Electric Power Regulatory Authority (Nepra) seeking approval to refund Rs4.84 per unit to its consumers in April bills. The proposed refund comes after the utility charged higher per unit electricity rates in January, 2025.

Govt raises RLNG prices for March

ISLAMABAD: The OGRA has raised the prices of imported RLNG for March, increasing costs for consumers of both SNGPL and SSGC.

Govt's sugar export policy backfires

ISLAMABAD: The flaws in the sugar export policy have been exposed, leading to a rise in sugar prices. The government is now planning to import sugar to float in the market and stabilise prices. K-Electric petitions for tariff cut of Rs4.84
