Rs265.745bn WHT paid in H1FY25: Salaried individuals emerge major contributor to kitty

ISLAMABAD: The salaried class became a major contributor to withholding tax payment during the first six months of 2024-25 paying Rs 265.745 billion during (July-December) 2024-25, reflecting an increase of 59.2 percent as compared to previous fiscal year.

Faceless customs system: Rs84bn collected in duties during Feb

KARACHI: The Collectorate of Customs Appraisement South Karachi has reported collecting Rs84 billion in customs duties under the faceless customs system during February 2025. According to the details, this revenue collection represents 52% growth compared to the Rs55 billion collected during the same period last year in February 2024.

KARACHI: Gold prices edged lower on Saturday as global bullion value continued to decline, nearing \$2,850 per ounce, traders said. Gold traded for Rs300,000 per tola and Rs257,201 per 10 grams, down by Rs500 and Rs438 respectively, APSGJA said.

Spot rate unchanged amid lacklustre business

LAHORE: The local cotton market on Saturday remained bearish and the trading volume remained low. Cotton analyst Naseem Usman told Business Recorder that the rate of cotton in Sindh as per quality is in between Rs 16,700 and Rs 17,800 per maund, while rates in Punjab were between Rs 17,000 and Rs 17,800 per maund.

Rs4.457tr in tax revenue stuck as over 108,000 cases pending in courts: report
