<u>**Iul import ebb to help arrest PKR slide: Miftah**</u>

ISLAMABAD: Federal Minister for Finance and Revenue Miftah Ismail said that the government's efforts to reduce imports have finally borne fruit and the country's import bill has decreased by \$2.7 billion as the country imported goods worth \$ 5 billion only in July as compared to \$7.7 billion in the previous month (June).

ISLAMABAD: The government Sunday night announced slashing the petrol price by Rs3.05 per litre, and increased the price of High-Speed Diesel by Rs8.95 per litre.

Rs20bn supplementary grant for PSO approved by ECC

ISLAMABAD: An urgently convened meeting of the Economic Coordination Committee (ECC) of the Cabinet has approved Rs 20 billion as supplementary grant for PSO to save it from being default on international payments and directed Finance Division and Federal Board of Revenue (FBR) to come up with a proposal for mobilizing Rs. 30 billion through taxes, within a week.

Port Qasim coal-fired power plant: Chinese propose use of RMB

ISLAMABAD: Chinese coal power producers have shared their concerns with Prime Minister Shehbaz Sharif and proposed use of RMB by Port Qasim coal-fired power plant to buy coal to release pressure on dollar, well informed sources told Business Recorder.

Sindh CM approves two new desalination plants

KARACHI: Sindh Chief Minister Syed Murad Ali Shah keeping in view the water requirement of the city has decided to install two new seawater desalination plants, each one of 5 million gallons per day (MGD), and to acquire a seawater desalination plant abandoned at KANUPP.
