ISLAMABAD: Chinese experts have said that there is a huge demand for maize silage in China, and the current production is not enough, therefore, they are eager to cooperate with Pakistan where varieties of sugar maize can be cultivated.

€100 million loan tied to Danish suppliers

ISLAMABAD: Public Procurement Regulatory Authority (PPRA) has raised concerns over the €100 million interest-free Danish loan facility being tied to Danish suppliers only.

Govt to borrow Rs6.8tr from banks

KARACHI: The government has planned to borrow Rs6.78 trillion from commercial banks over a period of two months – August and September 2022, mainly to repay previous loans and to finance its budget deficit.

SSGC to opt for gas load management
