Import ban doesn't apply to industrial inputs: ministry

ISLAMABAD: The Ministry of Commerce has clarified that the ban on the imported items under SRO598(1) 2022 shall not apply to raw material, intermediate goods and industrial equipment/machinery required by manufacturing/industrial concerns and foreign grant-in-aid projects.

Power tariffs raised by Rs4/unit for April

ISLAMABAD: National Electric Power Regulatory Authority (Nepra) has allowed power Distribution Companies (Discos) to increase their tariffs by Rs 4 per unit for April 2022 under monthly Fuel Charges Adjustment (FCA) mechanism, amid CPPA-G's acknowledgement that plants are not being operated due to expensive fuel and foreign exchange constrains.

Miftah says 'difficult to imagine buying Russian oil'

ICAP for withdrawing tax breaks
