ISLAMABAD: Prime Minister Shehbaz Sharif has said that the federal budget for next fiscal year 2022-23 represents a significant improvement in several ways.

Industrial amnesty scheme withdrawn

ISLAMABAD: The amnesty scheme (industrial package) announced by the previous government for the revival of sick units and promotion of industries has been withdrawn from March 2, 2022.

KE seeks payment of Rs25bn to clear SSGC dues
