MoF lists macroeconomic imbalances: Higher growth may not be sustainable

Miftah pins hopes on sealing IMF deal by June

ISLAMABAD: The government expects to reach a staff-level agreement with the International Monetary Fund (IMF) next month, Finance Minister Miftah Ismail said on Saturday, a day after the government ended a months-old freeze on fuel prices, reviving hopes that the country can unlock funding.

Hike in gas tariff by 40-50pc likely soon

ISLAMABAD: In a bid to restore the \$6 billion IMF programme, this time the government is left with no option but to increase the system gas tariff by around 40-50 percent as it is expecting the revenue requirement determination for financial year 2022-23 by OGRA in mid-June, a senior official at the Energy Ministry told The News. "The increase in gas tariff will be enforced from July 1, 2022."

Situationer: Water scarcity causes cotton acreage to shrink

LAHORE: Persistent water scarcity and heatwave has slashed cotton acreage to one of the lowest levels recorded in the last several decades. Already battered by scant canal supplies and above-normal temperatures, the latest drop in river flows further hits the cotton outlook for the farmers despite favourable marketing conditions on the back of record-high silver fiber prices.

Loadshedding to continue for next 2-3 months: minister

ISLAMABAD: The ongoing loadshedding will continue to haunt the masses for the next 2-3 months till the fiscal constraints of the government are done away with, Federal Minister for Power Division Khurram Dastgir Khan says this while talking to The News.

Miftah hopeful of IMF deal next month

ISLAMABAD: Federal Minister for Finance Miftah Ismail said on Saturday that the government took the tough decision to hike the POL prices by Rs30 per litre at the cost of political capital and hoped that the staff level agreement with the IMF would be struck in June 2022.
