KARACHI: A senior European Union diplomat on Monday indicated the "GSP+ status beyond 2023 is possible for Pakistan" as the federal government was committed to show compliance with the high EU requirements.

Gas companies 'may go bankrupt' without tariff hike, says Musadik

ISLAMABAD: With the gas sector's circular debt at Rs1.5 trillion, the Petroleum Division on Monday said the gas companies would go bankrupt without a hike in gas tariff that was now inevitable in view of the amended Oil and Gas Regulatory Act.

Govt lifts ban on import of raw materials

ISLAMABAD: The government has lifted a ban on the import of raw materials, intermediate goods and machinery for the industrial sector. A senior official in the commerce ministry told Dawn that a broader decision was taken and the ministry will soon work out the list of items that inadvertently fall in customs codes attracting ban under SRO598 issued on May 19.

Rupee gains another 70 paise against dollar

KARACHI: The US dollar lost another 70 paise against the rupee for the second consecutive session to close at Rs199.06 in the interbank market on Monday amid claims by the government that it will soon get \$1 billion from the IMF as the key precondition of raising petrol and diesel prices has been met.

Govt says increasing gas prices inevitable

ISLAMABAD: The government on Monday told a parliamentary panel that the two state-run gas distribution companies would go bankrupt if the gas prices were not increased. Especially, the Oil and Gas Regulatory Authority's new rules limit the power of the federal government to cap its prices so it becomes inevitable now.

APTMA says textiles are country's shield

ISLAMABAD: All Pakistan Textile Mills Association (APTMA) on Monday issued a rebuttal on an article 'Textiles, our Achilles heel' published on May 24. A historic cotton decline, gas and energy outages, billions of rupees in tax refunds, efficiency audits, labor and raw material shortages, and other issues have affected the industry considerably.

Petrol, diesel subsidy projected at Rs41.11, Rs53.14/ltr

KARACHI: The government has to pay Rs41.11 and Rs53.14 per litre subsidy on petrol and diesel respectively in the next fortnight (June 01 to 15, 2022) if prices are not raised, The News learnt on Monday.

More items exempted from import ban

ISLAMABAD: The government on Monday exempted the imports of raw materials, intermediatory goods, industrial equipment, and foreign grants in aid projects, after weighing in the complaints of stakeholders.

Private Haj pilgrims to pay airfares in dollars

KARACHI: For the first time in the country's history, the national flag carrier — Pakistan International Airline (PIA) — will charge airfares in dollars from Haj pilgrims flying on a private scheme. The airfares for the pilgrims from Southern region and Northern region are likely to remain in the range of \$810 to \$1,100 and \$860 to \$1,150 respectively.

SBP, finance ministry inflation forecasts clash

ISLAMABAD: State Bank of Pakistan's (SBP) macroeconomic approximations are higher than that of the finance ministry, especially inflation forecasts for the next budget 2022-23, The News learnt on Monday, and this clash is complicating the budget-making exercise.

Rupee extends gains

KARACHI: The rupee managed to post more gains against the dollar in both the currency markets on Monday. The local unit appreciated by 1.60 rupees versus the greenback in the open market. It was sold at 199.40, compared with 201 in the previous session.
