### COP27 summit cuts deal to fund climate damages

SHARM EL SHEIKH, (Egypt): A fraught UN climate summit wrapped up Sunday with a landmark deal on funding to help vulnerable countries cope with devastating impacts of global warming — but also anger over a failure to push further ambition on cutting emissions.

#### PM hails historic deal

ISLAMABAD: While welcoming the establishment of damage and loss fund to compensate the losses of poor countries affected by climate change in the COP 27 conference, the Prime Minister Shehbaz Sharif has stated that it is first step towards environmental justice.

#### Power projects: Huge receivables hurdle to new funding: China

ISLAMABAD: Beijing has reportedly conveyed to Islamabad that huge receivables of existing Chinese power projects are the main hurdle in convincing banks for further funding in other power projects to achieve their financial closures, well informed sources in federal government told Business Recorder.

#### Two fertilizer plants: Body formed to examine possibility of RLNG supply

ISLAMABAD: The Economic Coordination Committee (ECC) of the Cabinet has constituted an inter-ministerial committee headed by Secretary Industries and Production to examine possibility of supply of RLNG to Fatimafert and Agritech Fertilizer plants vis-à-vis import of urea to cater the requirement of urea in the country beyond December, 2022.

## IT, ST, FED: FBR plans ballot to select cases for audit

ISLAMABAD: The Federal Board of Revenue (FBR) is planning to conduct computerised balloting for selecting the cases of income tax, sales tax, and federal excise duty (FED) for audit for tax year 2019.

#### **Determined IT refund: Scam involving tax officials unearthed**

ISLAMABAD: Federal Tax Ombudsman Dr Asif Mahmood Jah has unearthed a unique kind of scam involving tax officials, who rolled back the determined income tax refund by creating some technical errors in refund ledgers of the taxpayers.

## BMP calls for smooth gas supply to industry during winter

LAHORE: Complaining about the energy shortages, the Businessmen Panel (BMP) of the Federation of Pakistan Chambers of Commerce and Industries (FPCCI) has asked the government to ensure smooth supply of gas during winters to the industrial consumers of Sui Northern Gas Pipeline Limited (SNGPL) and Sui Southern Gas Company (SSGC), as the government lacks a policy in this regard, compelling the industry to go for closure.

## Tea, coffee can be imported from Ethiopia at affordable rates, says envoy

KARACHI: Ambassador of Ethiopia and Plenipotentiary Jemal Beker Abdula has said that his country has surplus tea as well as coffee which can be exported to Pakistan at affordable rates.

## Sindh governor to lead delegation of businessmen to Ethiopia

KARACHI: Governor Sindh Kamran Khan Tessori has agreed to lead a delegation of Pakistani businessmen who was likely to fly to Ethiopia Airlines which will commence its flight to Karachi by the end of this year or January 2023.

## PKR declines on rising political noise, falling forex reserves

KARACHI: The rupee lost value, albeit marginally, in all five sessions during the previous week to close at 223.17 against the US dollar in the inter-bank market, amid reports that talks with the IMF have been further delayed as the lender linked arrival of its mission in Islamabad with finalisation of macroeconomic framework with necessary adjustments.

#### **Cotton imports: prognosis negative**

A major slowdown in textile exports is on the cards. Or at least that is the indication from the latest monthly trade report card from Pakistan Bureau of Statistics. Per PBS, the industry witnessed a double- digit decline in volume exported across most low to medium value-added segments during 4M-FY23 (July – Oct).
