Opposition protests against price hike begin

Chief Minister's House, Karachi, CM Sindh Murad Ali Shah pledged to implement minimum wage of Rs25,000 in all public, private organisations.

If it joins 136 countries' tax deal: Pakistan to get Rs26 bn extra tax annually, says OECD

Over 100pc hike in duties, taxes on cooking oil, ghee since 2018

LAHORE: The ruling Pakistan Tehreek-e-Insaf (PTI) government has increased more than 100 per cent duties and taxes on cooking oil and vegetable ghee since it come to power in 2018.

Dollar rises by 39.91pc, petrol soars 44.68pc in three years

LAHORE: During the 38-month rule of the incumbent Pakistan Tehreek-e-Insaaf (PTI), which had formally commenced on August 18, 2018 when Imran Khan was sworn in as country's 22nd Prime Minister, the parity of the Pakistani rupee versus the American dollar has worsened from Rs124 to Rs173.50 on October 20, 2021, while the petrol prices have surged from Rs95.24 to Rs137.79 per litre during the same corresponding period.

Rupee continues to slide, reaches another record low

KARACHI: Rupee reached a new record low on Wednesday, selling at 173.45 against the dollar in the interbank market to continue a slide that saw it lose more than 13.5 percent since May, dealers said.
